

# Human Rights Challenges Experienced by Perinatal Women Facing Severe and Multiple Disadvantage

## Introduction

This poster describes a current research project being carried out by Birthrights and Birth Companions which aims to investigate the human rights challenges experienced by women facing severe and multiple disadvantage during their maternity care. The project is funded by Trust for London.

#### **Background**

Many women still do not receive respectful care or choice in childbirth.<sup>1</sup> This problem is likely to be particularly acute for women who are facing severe and multiple disadvantage.<sup>2</sup>

In this project we use **severe and multiple disadvantage** to refer to sets of co-presenting needs, which may include:

- Housing problems, poverty and/or no access to public funds
- Perinatal mental health problems
- Physical and/or learning disabilities
- Substance misuse
- Social services involvement, or history of safeguarding issues
- Experiences of asylum, immigration and/or trafficking
- Isolation
- History of domestic abuse, sexual violence, human rights violations
- Experience of detention or imprisonment
- Language issues
- Experience of sex work

High-quality care, choice and control are strongly associated with positive experiences, birth outcomes and mother-baby relations.<sup>3</sup> Poor quality and disrespectful care are associated with trauma and post-traumatic stress disorder, particularly for women with a history of mistreatment.<sup>4</sup>

Women facing multiple disadvantage run a greater risk of experiencing care that fails to recognise their choices, because of the complexity of overlapping needs, and because they may not be well-placed to advocate for themselves.<sup>5</sup> They are less likely to access care, have poorer outcomes and are more likely to experience perinatal mental health problems.<sup>6</sup>

This project focusses on the experiences of women in London, where women with complex needs are over-represented in maternal deaths.<sup>7</sup>

#### **Objectives of research**

- To map the most frequent and severe rights-based issues which arise for women facing severe and multiple disadvantage during their care;
- To identify policy and practice changes to address these issues;
- To effect change and disseminate learning through multiple routes, including policy work, resources and training.

The project is strategically timed to feed in to the significant national and local change programmes set up to implement the 2016 NHS England National Maternity Review over the next two years.



#### Methodology

The project seeks to draw out rights-based challenges women face in the context of their maternity stories as a whole, because rights-based issues may not be recognised and articulated as such by women who have experienced them. The project is being overseen by a steering group of specialist midwives, researchers and women with lived experience.

#### Interviews

The first stage involves in-depth, semi-structured interviews with women who have recent experience of maternity care whilst facing severe and multiple disadvantage. Women are asked about their stories and experiences of maternity care. Through analysis, human rights issues are identified that may not be articulated as a rights breach during interviews.

#### • Focus groups

As a second stage of research, we are running focus groups with specialist and non-specialist midwives and birth supporters, and with child protection professionals to understand the challenges they face in supporting women facing severe and multiple disadvantage.
