# Child protection conference practice during COVID-19

Online survey questions (rapid consultation September–October 2020)

### About the survey

Child protection conferences are a key stage of the child protection system in England and Wales, where families and professionals come together to identify and address serious concerns. Since the outbreak of the COVID-19 pandemic and associated lockdown measures, professionals and families have had to rapidly adapt to remote or socially distanced conferences. The Nuffield Family Justice Observatory commissioned research to investigate what these changes have meant in practice. These survey questions form part of the research process, which took place between September and October 2020.
